# C. CONSOLIDATED VIEWS OF THE LOCAL ASSOCIATIONS UNDER MY JURIDICTION ON THE FUNCTIONING OF FPTA THIS QUARTER:

- <u>DRUPA VISIT</u>: It's commendable that Hiren Karia, as the convenor of the committee for international trade, organized the trip to DRUPA in Germany from India. Arranging accommodations and transportation for this delegation (PAN INDIA) must have involved meticulous planning and attention to detail. Ensuring smooth logistics contributes significantly to the overall success and experience of such international visits.
  A 7 member delegation from MPMA had joined the DRUPA program organised by FPTA and gave a great feedback regarding the trip experience overall.
- 2. IMPORTS (PIMS) GOVERNMENT POLICIES: PIMS (PAPER IMPORT MONITORING SYSTEM). This pertains to feeding of imported items in government portal (5-75 days before the arrival of imported goods. A request from our members to FPTA was to reduce this period to (1-75 days) as it is in the case for medical and steel imports.
- **3. INFORMATION**: Members are happy with the updated information shared by all the committees of FPTA. They feel it prompt and useful.
- **<u>4.</u> <u>FUNCTIONING:</u>** Members express high levels of satisfaction with the functioning of the Federation of Paper Trade Association (FPTA).

# D. TOUCH WITH FPTA PRESIDENT SHRI DALIP BINDAL, SECRETARY SHRI BAVESH GALA FPTA SECRETARIAT ON THE FOLLOWING MATTERS:

Webinar, planning for president visit to my affiliated associations, Sri Lanka MC Meet and KYM Forms.

I regularly provide updates to the esteemed FPTA President, Shri Dalip Bindal, and Secretary, Shri Bavesh Gala, regarding the latest developments within my jurisdiction.

#### E. SUGGESTIONS FOR IMPROVISING ON FPTA ACTIVITIES

- 1. <u>LIFE MEMBER & PATRON</u>: Certain members registered under Life member / Patron want to understand the benefits of being the same. They wish to have a better clarity from FPTA regarding their entitlements apart from voting rights, as hardly they get an opportunity to interact with FPTA directly.
- **2. FSC Certification**: Traders who are registered with FSC are facing a challenge and wish FPTA's support in giving them a better solution. FSC certification requires a premium to be paid for goods under FSC certification, whereas the certifying agency charges a premium for the entire turnover of the trader.

They are unable to fetch this premium for regular sale in the market, so this advantage of being certified is lost due to additional charges.

- 3. **GUIDANCE**: Affiliated associations to FPTA can work better and more efficient if there is a standard guideline or framework. Request senior members to consider this request and frame one.
  - Every local association has got its AGM yearly once or in two years, this framework would be supportive for the incoming team to relate with FPTA.
- 4. **WATZPP GROUP MONITORING**: FPTA's key role is to promote better trade and trade practice in our industry. In case of a slow demand, request members not to ponder too much over the same and request any negative propagation to be avoided.
  - In our official watzapp group, admin to take more control of the same and encourage statements having statistical value only. Since words of elected members have high value, any unwarranted statements or assumptions in this group can have deep detrimental value of market sentiments.
